**ASSUMPTION OF RISK, RELEASE AND WAIVER OF LIABILITY AND INDEMNITY**  
**AGREEMENT & RIDER ENTRY FORM**

IN CONSIDERATION OF BEING PERMITTED TO ENTER FOR ANY PURPOSE (either as a spectator, rider, pit crew, support crew, event participant, concession operator/vendor or any other purpose) IN ANY AREA (herein defined as including, but not limited to, the parking lots, spectator areas, racing surface, pit areas, infield, approach area, and all walkways, playgrounds, concessions and other areas appurtenant to any area where any activity of any nature related to the event shall take place), or being permitted to practice race, run, operate any vehicle of any type or native, compete, officiate, observe, work for, or for any purpose participate in any way in the event, **EACH OF THE UNDERSIGNED**, for himself/herself, person representatives, heirs, successors or assigns, acknowledge, agree and represent that he/she has, or will immediately upon entering any of such restricted area, and will continuously thereafter, inspect such restricted area and all portions thereof which he/she enters and with which he/she comes in contact, and he/she does further warrant that his/her entry upon such restricted area or areas and his/her participation, if any, in any event or use of the restricted area, constitutes an acknowledgment that he/she has inspected such restricted area, and assumes the risk, if any, of the condition, terrain, track, jumps, pit area, spectator area and all other areas on the property, and that he/she finds and accepts the same as being safe and reasonably suited for the purposes of his/her use, and he/she further agrees and warrants that if, at any time, he/she is in or about the restricted area and he/she feels anything to be unsafe, he/she will **immediately notify the officials, or JTeamRacing LLC**, of such and will leave the restricted areas.

By signing this release and waiver the undersigned agrees that he/she shall not be required to re-sign or execute any other or subsequent releases hereafter, and covenants and warrants with JTeamRacing LLC, its officers, managers, employees, owners and all others that this release and waiver shall be valid and enforceable at all future events and times at JTeamRacing LLC for any purpose or use made by the undersigned at JTeamRacing LLC, even unlawful or uninvited entry, until revoked in writing by the undersigned with Notice of Revocation delivered to JTeamRacing LLC's designated manager, Bob Jandebour. In the event of Notice of Revocation, the undersigned shall immediately be removed from the premises and denied future entry until a new release and waiver is executed and delivered to JTeamRacing LLC. If the undersigned fails to deliver a new release and waiver before entry to JTeamRacing LLC property, then the entry shall be deemed a trespass and no duty shall exist to the undersigned.

**1. THE UNDERSIGNED HEREBY RELEASE, WAIVE, DISCHARGE AND COVENANT NOT TO SUE JTeamRacing LLC**, for any use, injuries, damages, claims, event promoters, participants, racing association, sanctioning organization or any subdivision thereof, track owner, officials, motocross bike or Quad owners, drivers, pit crews, any persons in restricted area, sponsors, advertisers, owners and lessees of premises used to conduct the event and each of them, their respective officers, employees, agents and representatives, all for all purposes thereafter referred to as "releasees", from all liability to the undersigned, his/her heirs, personal representatives, successors and assigns for any and all loss or damage, and any claim or demands therefore on account of injury to the person or property or resulting in death of the undersigned, whether caused by the negligence of the releasees or otherwise while the undersigned is in, or upon, the restricted area, and/or practicing, running, participating, viewing, competing, officiating in, observing, working for, or for any purpose participating in the event or using the restricted area.

**2. THE UNDERSIGNED HEREBY AGREES TO INDEMNIFY AND SAVE AND HOLD HARMLESS** the releasees, and each of them, from any loss, liability, damage, or cost they may incur due to the presence of the undersigned in or upon the restricted area or in any way competing, officiating, observing, or working for or for any purpose participating in any event and whether caused by the negligence of the releasees or otherwise, including all attorney fees and costs of JTeamRacing LLC and its employees.

**3. THE UNDERSIGNED HEREBY ASSUMES FULL RESPONSIBILITY FOR AND RISK OF BODILY INJURY, DEATH OR PROPERTY DAMAGE** due to the negligence of the undersigned or releasees or otherwise while in or upon the property and/or while competing, officiating, observing, or working for or for any purpose participating in the event or using the restricted areas.

**EACH OF THE UNDERSIGNED expressly acknowledge and agree that the activities of the event or any use of the restricted area are very dangerous and involve the risk of serious injury and/or death and/or property damage, and that JTeamRacing LLC does not carry any track medical Insurance coverage and is the full and total responsibility of the undersigned.**

**EACH OF THE UNDERSIGNED further expressly agree that the foregoing release, waiver and indemnity agreement is intended to be as broad and inclusive as is permitted by the laws of the State of Oklahoma, and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full, legal force and effect. FOR A MINOR, PERSONS UNDER THE AGE OF 18, NO ENTRY OR USE OF THE PROPERTY IS PERMITTED WITHOUT THIS RELEASE BEING SIGNED BY THE PARENT/GUARDIAN. CHILDREN UNDER THE AGE OF 11 ARE NOT PERMITTED TO RIDE ALONE AND MUST BE SUPERVISED AT ALL TIMES BY A RESPONSIBLE ADULT.**

THE UNDERSIGNED HAS READ AND VOLUNTARILY SIGNS THIS RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT, and further agrees that no oral representations, statements or inducements, apart from the foregoing written agreement, have been made.
